Michael was born and raised in New Dorp, Staten Island. After Graduating Petrides High School, Mike enlisted in the Army. While in the Army, he served with distinction in the 1st Armored Division, 101st Airborne and the 10th Mountain Division. He was also a Ranger

and a recipient of the Silver Star. He was Killed in Action on August 28th, 2013 while on his 3rd overall deployment.

5. VA Choice Program Rollout. The Veterans Access, Choice and Accountability Act required VA to start implementation of the Choice Program by November 5, 2014. Starting this week, veterans who live 40 or more miles away from a VA medical facility will have the opportunity to choose whether to receive their health care at VA or in their community, through non-VA doctors. Veterans who live within 40 miles of a VA medical facility, but are currently waiting longer than 30 days for VA care will begin receiving their cards later this month. VA expects that all veterans who were enrolled in the VA health care system on August 1, 2014, will receive their cards by January 2015. However, receiving a Veterans Choice Card does not instantly authorize you to start receiving health care from non-VA doctors. All care received through the Choice Program must be pre-authorized and coordinated by VA.

- 3. The Defense POW/MIA Office announced the identification of remains belonging to the following personnel. Returned home are:
- * Army Air Forces Maj. Peyton S. Mathis Jr., 28, of Montgomery, Ala. On June 5, 1944, Mathis was piloting a P-38J Lightning when the aircraft lost power while attempting to land at Kukum Air Field on Guadalcanal Island in the Solomon Islands. A rescue team located the crash site but was unable to recover Mathis because the aircraft was submerged in a dense jungle swamp.
- * Army Cpl. Francis D. Knobel, 20, of La Crosse, Wis., was assigned to Headquarters Company, 3rd Battalion, 31st Infantry Regiment, 7th Infantry Division, when he was lost Dec. 12, 1950, in North Korea.
- * Air Force Col. William E. Cooper, 45, of Albany, Ga., was assigned to the 469th Tactical Squadron, 388th Tactical Fighter Wing, when his F-105D Thunderchief was shot down while on a strike mission on a highway-railroad bridge north of Hanoi, North Vietnam, on April 24, 1966.
- * Marine Corps Pvt. Jack M. Redman, 20, from Watseka, Ill., was lost on Nov. 20, 1943, during the Battle of Tarawa. He was assigned to Headquarters Company, 3rd Battalion, 6th Marine Regiment.
- * Army Sgt. Joseph M. Snock Jr., 21, from Westmoreland, Pa., was lost on Nov. 30, 1950, in North Korea, where it would be learned he died as a prisoner of war. He was assigned to Heavy Mortar Company, 31st Infantry Regiment.
- * Army Sgt. 1st Class James W. Holt, 26, of Hot Springs, Ark., was lost Feb. 7, 1968, in Vietnam. He was assigned to Company C. 5th Special Forces Group.
